& A.B. 8867) a bill incorporating animal dentistry into the veterinary medicine practice act. The bill was signed into law August 11, 2014 by our governor and immediately took effect upon signature. New York State joined our neighbors, New Jersey, Pennsylvania, Connecticut, Massachusetts, Vermont and Maryland, all who implemented these changes earlier. Additionally, the Veterinary Medicine Mobility Act (H.R. 1528) was signed into law by the president. Thank you for all your hard work and efforts. Our memberships efforts were substantial enough to support these bills. At this time we need your continued support to defeat the Fairness to Pet Owners Act (H.R. 4023). Please contact your congressional representatives and senators to protect our patient's safety.

Our annual summer baseball outing on August 16th was a success (except for the Staten Island Yankees!). It was a beautiful evening and many VMANYC members, friends and family enjoyed the outing. The NYS Veterinary Conference is right around the corner with a great line-up of speakers presenting a progressive continuing education program.

The executive Board has been busy over the summer. The Board is scrutinizing our by-laws, establishing a local veterinary outreach program, constructing a dental brochure for members to handout and much more. Stay tuned.



Dr. Ann Hohenhaus Wins the Prestigious DeBakey Journalism Award

YARDLEY, PA – Vetstreet.com and the Animal Medical Center in New York City today are pleased to announce that Dr. Ann Hohenhaus has won a prestigious 2014 DeBakey Journalism Award in the Online category for her article "<u>Dogs Go To Bat Against Lou Gehrig's Disease.</u>" The award will be presented tonight at an awards dinner ceremony in Washington, DC, hosted by the Foundation for Biomedical Research (FBR).

The article was inspired by Dr. Hohenhaus's attendance at the November 2013 Zoobiquity Conference in New York City, an event that seeks to highlight connections between human and animal health. In the article, Dr. Hohenhaus recounts the work of Missouri University veterinary neurologist Dr. Joan Coates and how it has positioned dogs and canine research models to be key players in understanding more about both ALS and DM. Dr. Coates' multi-institutional research is backed by funding from the National Institutes of Health and the ALS Association.

"Veterinarians play a crucial and ever-expanding role in demonstrating the interdependence of species; medically, environmentally, and emotionally. That the DeBakey Award has been given to a veterinary journalist highlighting the important work of a fellow veterinary practitioner and researcher is a tribute to the profession," said Dr. Beth Thompson, Medical Director and Publisher of Vetstreet.com and *Healthy Pet* magazine. "Vetstreet.com is honored to have such a distinguished contributor and advisor on our team and we congratulate Dr. Hohenhaus on her award," Dr. Thompson added.

News From the AVMA

Veterinary Medicine Mobility Act is now law

On Aug. 1, President Barack Obama signed into law the long-awaited Veterinary Medicine Mobility Act (H.R. 1528), making it legal for veterinarians to provide complete medical care to their patients beyond their clinics and across state lines. This is a major victory for the veterinary profession and the healthcare of our nation's animals!

The AVMA had been diligently working on getting this bill passed for nearly two years. The association's Governmental Relations Division met with the Drug Enforcement Administration and members of Congress and their staff many times to explain why a restrictive provision within the Controlled Substances Act needed to be amended so veterinarians would be permitted to use all of the medications available to provide the best care for their patients beyond their clinics. The AVMA helped raise awareness by running several advertising campaigns in D.C. publications, conducting interviews with media, and developing many communications resources to help educate our members, the public and Congress on the importance of this bill.

Over 130 veterinary medical and other organizations joined the AVMA in its advocacy efforts. Those efforts were amplified with the help of AVMA's members, who rallied together in an urgent call to action, sending more than 27,000 letters to their elected officials in support of the bill.

What's next? The AVMA has developed an FAQ document for members and is in the process of updating tools on DEA registration numbers to help members better understand how this new regulation directly affects them. In the meantime, we advise any veterinarian who is unclear about how to comply with the new law to consult the Diversion Control Program Manager at their respective Drug Enforcement Administration field offices for more information.

The AVMA would like to thank everyone for their outpouring of support for this bill. It proves that together, we can accomplish great things on behalf of the veterinary profession!
